COVID-19 WAIVER AND INDEMNIFICATION

COVID-19 is a viral disease that can be easily spread from person to person. As a result of its impact on our State and nation, both the federal government and the State of Connecticut have recommended social distancing and prohibiting the congregation of groups of people.

Newtown Centre of Classical Ballet & Voice ("NCCB&V") has and will continue to take reasonable preventative measures to reduce the spread of COVID-19 at its premises and by the conduct of its employees, officers, and/or agents. However, NCCB&V cannot guarantee that one or more of its students will not become infected with COVID-19.

Symptoms of COVID-19 include:

- Fever
- Fatigue
- Cough
- Shortness of breath or difficulty breathing
- Sore throat
- Chills
- Muscle pain
- New loss of taste or smell

I have reviewed the above symptoms and agree not to allow my child to engage in NCCB&V classes or activities if the following conditions exist:

- (A) I or any member of my household:
 - (1) Currently have the above symptoms; or
 - (2) Have experienced the above symptoms WITHIN THE LAST 14 DAYS.
- (B) I or any member of my household have been diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.
- (C) I or any member of my household have knowingly been exposed to anyone diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.
- (D) I or any member of my household have traveled outside of the country, or to any city considered to be a "hot spot" for COVID-19 infections WITHIN THE PAST 30 DAYS.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and, on behalf of myself, my child who is participating in NCCB&V classes and activities, as well as all other minors residing in my home or under my care, and my heirs, hereby assume all risks and all responsibility, and agree to release NCCB&V, including its employees, officers, and/or agents for any illness, injury, or death that may occur from contracting COVID-19, as well as any costs, judgments, or settlements which may be brought or entered against them as a result of my child's participation in NCCB&V classes or activities.

On behalf of myself, my child who is participating in NCCB&V classes and activities, as well as all other minors residing in my home or under my care, and my heirs, agree to hold harmless, defend, and indemnify NCCB&V, including its employees, officers, and/or agents from all losses, claims, suits, or causes of action by others for illness, injury, or death which may arise out of any of such persons contracting COVID-19, including claims arising from the negligence of NCCB&V, its employees, officers, and/or agents.

I HAVE READ THIS DOCUMENT AND BY SIGNING I AGREE IT IS MY INTENTION TO ACCEPT LEGAL RESPONSIBILITY AND PAY FOR ANY LOSS FOR CLAIMS OR LAWSUITS AGAINST NCCB&V, INCLUDING ITS EMPLOYEES, OFFICERS, AND/OR AGENTS, ARISING FROM THE PARTICIPATION OF MY CHILD, _______, IN NCCB&V CLASSES AND ACTIVITIES. I HAVE HAD THE OPPORTUNITY TO ASK ANY QUESTIONS ABOUT THE INDEMNIFICATION AND HOLD HARMLESS CLAUSES AND I UNDERSTAND THEIR TERMS AND MEANING.
